REINSW SUBMISSION IN RESPONSE TO THE DISCUSSION PAPER – INDEPENDENT REVIEW OF SWIMMING POOL BARRIER REQUIREMENTS FOR BACKYARD SWIMMING POOLS IN NSW

We refer to the submission prepared by The Real Estate Institute of New South Wales (**REINSW**) dated 19 October 2015 in response to the Discussion Paper on the independent review of swimming pool barrier requirements for backyard swimming pools in New South Wales (**Submission**).

Subsequent to lodging the Submission, an article came to our attention which supports REINSW's concern that councils do not have sufficient resources available to implement the changes to the *Swimming Pools Act 1992* (NSW) with respect to compliance.

We **enclose** the article from 9NEWS dated 20 September 2015 which discusses the "Fit For The Future" report prepared by the Independent Pricing and Regulatory Tribunal (**Report**).

According to the Report:

- (a) 71% of Sydney metropolitan councils and 56% of regional councils are not fit to continue operating in their existing capacities; and
- (b) local government in NSW is "broken" and amalgamating different councils would result in approximately \$2 billion savings over 20 years.

The article also outlines which councils are fit and unfit across NSW.

REINSW is concerned that 71% of Sydney metropolitan councils and 56% of regional councils do not have sufficient resources available to carry out their current role, let alone their additional requirements associated with swimming pool compliance. It is proposed that the amalgamation of different councils may present a solution to the problem, however, such council restructures are unlikely to take place before 29 April 2016 when swimming pools must be compliant.

REINSW would like the Government to take these facts into account whilst considering its Submission and is more than happy to discuss further should the need arise.

71 percent of Sydney councils 'not fit' for future operation: report

September 20, 2015: A damning report from an independent regulator is likely to force many of NSW's councils into mergers.

Local government in NSW is "broken" and amalgamating many councils, including the state's largest Local Government Area the City of Sydney, would save about \$2 billion over 20 years - according to a new report.


Compiled by the Independent Pricing and Regulatory Tribunal (IPART), the "Fit For The Future" report said 71 percent of Sydney metropolitan councils and 56 percent of regional councils are not fit to continue operating in their existing capacities.

The findings were partly based on proposals submitted by councils which outlined future plans including financial stability, scale and capacity.

Only Bankstown, in Sydney's south west, was deemed a "fit" council within the pool of all inner metropolitan Sydney councils.

Sutherland Shire, The Hills Shire and Blue Mountains City all received glowing reviews, with Campbelltown City Council and Willoughby City Council on the "not fit" list.

Controversially The City of Sydney was also deemed unfit.

"Mergers deliver significant benefits to participating councils, including improving a council's scale and capacity, and financial outlook," the report states.

The report was presented by Premier Mike Baird and Local Government Minister, Paul Toole.

The findings are expected to be received with hostility and disagreement by Sydney councils.

A statement from the Lord Mayor of Sydney, Clover Moore, said the report bared no "community support or evidence" to declare the City of Sydney unfit. "The impact of a forced amalgamation now would risk our 10-year, \$1.94 billion infrastructure program as well as \$30-40 worth of private development over the next decade.

"To say the City of Sydney is somehow unfit in the face of this strong evidence to the contrary makes a mockery of the entire review process, and throws into question all decisions made as a result."
